If you are unhappy with the decision of an agency or minister under the <a href="#">Freedom of Information Act 1982</a> (Cth) (FOI Act), you can:	如果您对某一机构或部长根据 <a href="#">Freedom of Information Act 1982</a> (Cth) (FOI Act) 作出的决定不满意，您可以采取下列做法：
<ul style="list-style-type: none"> <li>• apply for internal review by asking the agency or minister to reconsider their decision, so long as the agency head or minister did not personally make the decision</li> </ul>	<ul style="list-style-type: none"> <li>• 要求内部复查，只要该决定不是由该机构的领导人或部长亲自作出的，就可以请该机构或部长重新考虑他们的决定。</li> </ul>

There is no fee for requesting a review.	要求复查是不必交费的。
In most cases you must apply for IC review within 60 days of being notified of the minister's or agency's decision. You must apply within 30 days if you are requesting review of a decision to grant access to documents to another person. You can also ask the Information Commissioner to grant you more time to apply for IC review.	在大多数情况下，您必须在被告知部长或该机构的决定之后 60 天内申请信息专员 (IC) 复查。如果您要求复查关于允许他人查阅文件的决定，那么您必须在 30 天内提出申请。您也可以向信息专员要求允许您有更多的时间来申请 IC 复查。
